

Banking Information

Banking Information is required to complete your set up and enroll participants.

In order to establish Difference Card Benefits, a bank account must be provided to fund claim activity. This bank account is used for funding claim activity and invoice activity. The bank account is owned by you, the Employer. Some clients prefer to use a zero balance account or set up a separate bank account for Difference Card Benefits. Clients with Flexible Spending Accounts may also want to establish a separate bank account for those reimbursements, although this is not required.

Participants may use debit cards (if offered), sign up to receive direct deposit or request reimbursement via check. Claims reimbursed via debit card or direct deposit will be drawn via ACH pull from the account you indicate below. Checks will be written from the account provided by you. Direct deposits and checks are issued daily to your employees to get reimbursements as quickly as possible. The Difference Card will not have signing authority or access to this bank account. Any stop payment requests or inquiries on the status of checks can only be authorized by the client.
